Special guest speakers for this year's luncheon include Mr. Jason Rowley, President, Phoenix Suns, who will share his insight in the overall business management of the Suns and oversees the club's interests in the management of Talking Stick Resort Arena. Rowley has spent 11 years with the Suns, including 6 years as president. Joining Mr. Rowley will be Bobby Dulle, Chief Operating Officer of Phoenix Rising FC. Now in his 2nd year, Mr. Dulle is responsible for the management of all business operations and is playing a critical role in Phoenix Rising FC's push to the MLS. The final panel speaker is Mr. Josh **Rawitch**, Senior Vice President of the Arizona Diamondbacks, Mr. Rawitch is in his 23rd season in Major League Baseball and his 2nd year as Sr. Vice President for Content and Communications. He is responsible for all internal and external communications for the franchise. These speakers will touch on many topics, including:

- How to make the in-venue sports experience more affordable in an ever-increasing escalation of salary caps and franchise operating expenses that continue to pressure franchise owners and venue development executives;
- How to manage the competition between a live, in-game experience and the comfort of watching a game in high definition at home;
- How to find more uses for facilities to justify the cost of construction and the utilization of public money;
- How to diversify the demographic of the typical sports fan to maximize greater attendance and compete with other entertainment options;

 How to keep up with ever-evolving technology that leaves stadiums built a few years ago in need of constant upgrades.

The speakers will be introduced and the discussion facilitated by **Ralph Marchetta**, General Manager and Sr. Vice President, Talking Stick Resort Arena. Mr. Marchetta has been with Talking Stick Resort Arena since prior to its opening in 1992. He has extensive experience servicing professional sports teams that include the Phoenix Suns, Phoenix Mercury and the Arizona Rattlers, in addition to booking acts as diverse as U2, Bruce Springsteen, Lady Gaga and Andrea Bocelli. In addition to his work with Talking Stick Resort Arena, Mr. Marchetta serves as Chairman of the Board of Phoenix Sister Cities.
